SYEDNA MUFADDAL SAIFUDDIN'S TUS **FAMILY REUNITED AFTER 15 MONTHS**

US COURT GRANTS PHYSICAL CUSTODY TO FATHERS IN BEST **INTERESTS OF CHILDREN**

Uaipur , Apr-2015| The nearly 15 months ordeal for the minor children of the family of His Holiness Syedna Mufaddal Saifuddin (TUS), the 53rd Dai al-Mutlaq and head of the worldwide Dawoodi Bohra Community ended with their return to India recently with their fathers and His Holiness to a warm welcome by the Community.

On 3rd March 2015 the Bakersfield Family Court handed down its final decision granting sole physical custody of the children to their respective fa-

liness Syedna Mufaddal Saifuddin (TUS) and the other his nephew.

In January 2014, the mothers had abducted these children without the knowledge or consent of their fathers on the very day that their great grandfather His Holiness Dr. Syedna Mohammed Burhanuddin (RA) passed away and taken them to Bakersfield, California. After fleeing to California, the two mothers filed false domestic violence petitions in the Bakersfield Family Court which they never served on thers – one the son of His Ho- the fathers and concealed the



children and prevented the fathers from having any contact with them for several months. Despite this, the "the two fathers voluntarily appeared in the Bakersfield Family Court and resolutely defended themselves and only sought the return of their children and successfully proved that the mothers' claims of domestic violence were false," said Shab-Abidali, the legal coordinator for His Holiness's

The final decision came after an intense trial spread over five months in which the Bak-

ersfield Family Court held that the two mothers' claims of domestic violence by the fathers were "not credible"; that the mothers were simply using the minor children to further their father Khuzaima Qutbuddin's claim to succession as Dai al-Mutlag; and that the mothers emotionally abused the children by denying then any contact with the fathers for several months.

The Court further held that California was not the home state of the children and that India was. The Court granted physical custody of the children solely to the fathers to protect them from further abuse by the mothers and held that this was "to protect the minor children and in the children's best interest."

On their way back to India, the children accompanied by their fathers and His Holiness stopped in Cairo, Karbala and Najaf to offer prayers at the holy shrines there. Last week, they finally paid their last respects to their great grandfa---ther at the Raudat Tahera Mausoleum in Mumbai, and fulfilled a significant void in their lives.

global roadshow for the Resurgent Rajasthan Partnership Summit. On Thursday, she interacted with select members of the Kansai Economic Federation and the Japan External Trade Organization in Osaka, said a press release from the Chief Minister's Office.

"We have come a long way. This is an opportune time to reenergise our relationship and work with Japanese authorities and the business community to secure a better future for Rajasthan," Raje said. "I look forward to a long and sustained relationship between Rajasthan and Japan," she added.

Raje also met Masayuki Matsushita, the vice-chairman of Panasonic Corporation, and made a pitch for Rajasthan as an investment destination, the release added.

The meeting was followed by a visit to the Daikin global headquarters in Osaka. Daikin has a significant operation in the Japanese Zone in Neemrana, Rajasthan. Daikin president Masanori Togawa said he looked forward to the day when his company's Rajasthan operations would become the source of exports to South-East Asia and the Middle East.

Raje invited Noritake, a world leader in ceramics, to consider Rajasthan as a place to set up a plant in the state. Noritake chief Tadashi Ogura said his company would scout Rajasthan before taking a call on investment.

New Delhi, Chief minister Vasundhara Raje met Japanese Prime Minister Shinzo Abe on Monday. The Japanese PM assured Raje of increased investment in the state and said that his government and investors were closely monitoring the investment climate in Ra-

Welcoming Raje to Japan, Abe said, "India and Japan are friends. Japanese companies are being encouraged to invest overseas and it is likely that Rajasthan too shall see increased investment flow from Japan." Raje also met Hideaki Domichi, Japan International Cooperation Agency (JICA) president and outlined areas where Rajasthan could look for support from JICA. Madhav Singh Devdra found murdered


UDAIPUR: A 55- year- old man was found murdered with his head completely crushed, in Debari Panchayat area here on Wednesday morning. The deceased was identified as Madhav Singh Devdra (55), a resident of Sangatwado Ka Wada under the Debari Panchayat area.

During investigation, the police learnt that Devdra used to go for an evening walk regularly. He reportedly went for the walk on Tuesday evening. When his son, Nahar Singh, did not find him at home on Wednesday morning, he began searching for him in the village and found his father's body in a farm belonging to a neighbor, Vijay Singh

Devdra's body was crushed with a heavy object, said Chandra Purohit, station house officer of the Pratap Nagar police station. The police were apprehensive about robbery as the motive behind the murder, as gold earrings worn by the victim were found intact. The body was handed over to the relatives after postmortem.

High court rejects Salman Khan's plea in Arms Act case JODHPUR: The Rajasthan high

court has rejected actor Salman Khan's plea against a trial court order allowing four more witnesses in the Arms Act case in connection with the 1998 blackbuck poaching incident. The examination of these four new witnesses will now begin in the chief judicial magistrate court, Jodhpur district, on Monday. The actor had moved an application in the high court with a plea to quash the order of the lower court, in which the court had allowed the prosecution to summon four witnesses pertaining to the case. Justice Nirmaljeet Kaur had reserved the decision in the matter after hearing the arguments of both the sides. On Friday, justice Kaur upheld the decision passed by CJM Anupama Bijlani on March 3 to be in accordance to the law.

The CJM court, in its order had accepted the application by the prosecution and allowed to record the statements of four witnesses, despite the finale argument in the matter was already over. Salman Khan's counsel Mahesh

Bora, while challenging the decision in high court had argued that summoning the fresh witnesses at the time when the finale argument was over was not justified and in accordance to the law.

The CBI court has sent chief income tax commissioner, Jodhpur zone, PK Sharma, to 14 days judicial custody on Friday. Sharma was arrested recently after he was caught accepting `15 lakh bribe for settling an assessment case. The CBI sleuths produced Sharma before the court on Friday morning after which he was sent to the judicial custody.

On Thursday evening, income tax officer Shailendra Bhandari, who was also arrested along with Sharma in the bribery case, was produced before the CBI court. Bhandari too was sent to judicial
