## Pre-school Education to Start in 61,000 Aanganbari Kendras for Holistic & Integrated Development of Children

Jaipur, The State Cabinet in its meeting on Wednesday decided to start pre-school education under Early Childhood Care and Education (ECCE) Policy. The move will help in promoting the holistic and integrated development of children below 6 years through 61,000 Aanganbari Kendras in the state. The Cabinet Meeting was presided over by Chief Minister Smt. Vasundhara Raje.

After the cabinet meeting Parliamentary Affairs Minister Shri Rathore while talking to media persons informed that for the effective implementation of the ECCE Policy a General Council will be formed under the Minister for Women & Child Development while Executive Counil will be formed under the Principal Secretary of the Women & Development Department. Shri Rathore informed that two teams lead by two senior IAS officers have reached to help the Rajasthanis stranded in Nepal after the recent earthquake. He informed that to bring stranded people 5 buses of RSRTC have been



affected persons have reached here and a truck carrying relief material has reached Nepal. Chief Minister Smt. Vasundhara Raje herself is monitoring the progress of relief and rescue operation, he said. Shri Rathore said the Cabinet gave approval to the closure of Rajasthan State Coal Mining Company Ltd as Rajasthan Vidyut Utpadan Nigam has become eligible for allotment of coal mine under the ordinance of Govt of India issued on December 27, 2012. After the permission of the state government RVUNL allotted Kante Extension Coal Block having the capacity of 200 million tonne. In this circumstances there is no utility of Rajasthan State Coal Mining Company Ltd. The Parliamentary Affairs Minister

said decision was taken regarding closure of Rajasthan Vaterinary Services Corporation Ltd as no medicines were procured through this company after its establishment. The purchase of medicines will be made by the Animal **Husbandry Department** under Pashudhan Nishulk Arogva Yoiana.

Shri Rathore informed that the Cabinet also gave approval to the decision to reject the work order of the tender given to M/S Passavant Roediger GMBH for laying sewerage lines in Nathdwara city. The tenders were invited of Rs. 28.60 crore but the work orders were issued of Rs. 41.07 crores. The Cabinet Sub-Committee had found various irregularities in the work

order and no global tender was invited before giving work order to the foreign company. Notices have also been issued to the Chief Engineer and other officers after the irregularities found in investigation.

The Parliamentary Affairs Minister informed that the cabinet gave approval to the Rajasthan Prevention and Control of Infectious and Contagious Diseases in Animals (Check Post and Quarantine Camp, Manner of Inspection, etc) Rules, 2014. The Rules have been formed to ascertain that whether the animal is infected with any of the scheduled notified disease, the animal stopped at the check post or detained in the quarantine camp shall be inspected by the person incharge of the check post.

The Cabinet gave approval to amendment in Rule 24B of the Rajasthan Medical & Health Service Rules, 1963 for removal of anomalies in promotion and Grade Pay of Medical Officers and equivalent posts under Dynamic Assured Career Progression Scheme (DACP). The decision will give benifit to 1180 doctors who are getting less salary than their juniors.

The Cabinet also gave nod to the draft of Maharshi Arvind University, Jaipur Ordinance, 2015. The decision to name Govt. College, Anupgarh as Seth Biharilal Chhabra Govt. College, Anupgarh was also taken by the cabinet. The Parliamentary Affairs Minister informed that it was also decided during the cabinet that cabinet meeting will be held every week. After the cabinet meet review of 4-4 departments will be made by the five groups headed by senior Ministers. Shri Ratohre informed that Rs. 936 crore have been allotted to various district collectors to distribute in the affected areas of natural calamity. He informed that Chief Minster is review-

### State circumstances should be taken into account while making centrally-sponsored schemes: CM

Jaipur, Chief Minister Smt. Vasundhara Raje has suggested that special circumstances and the basic facts like total area, geographical conditions, availability of natural resources, conditions of drought or famine, cost of service delivery in a state should be considered while deciding standards for centrally-sponsored schemes. Also, the budget allocation process for CSS should be fully transparent, she said.

Smt. Raje was addressing the second meeting of the Chief Ministerial sub-group of NITI Aayog to propose suggestions in regard to the rationalization of centrally-sponsored schemes. Chief Minister of Madhya Pradesh Shri Shivraj Singh Chauhan, who is the convener of the sub-group; Vice Chairman of NITI Aayog Shri Arvind Pangaria also attended the meeting. The CMs of Manipur, Arunachal Pradesh, Jharkhand etc and the Finance Minister of Jammu-Kashmir also presented their views during the meeting.

The CM expressed her gratitude to the Prime Minister for increasing the allocation to the states from the centre by 10 percent and suggested to ensure that amounts received by the states should not be decreased as per the Finance Commission recommendations. She demanded for giving rights to the states, including Rajasthan, to prepare schemes as per special circumstances of the states and their local needs.

Smt. Raje argued for reducing the number of centrally-sponsored schemes to 10, while continuing the schemes of national importance like education, health, employment etc. She suggested for similar 'funding pattern' across the country for implementing these schemes and said that entire funding of the entitlement Act-based centrally-sponsored schemes should be from the centre. For rest of the schemes the funding ratio of the centre and the states should be 75:25, she added. She further said that for better and effective implementation of the schemes, funds from the centre be released in two installments in April and September, instead of doing it at the year end.

The Chief Minister suggested to use the Chief Minsiters' sub-group in the NITI Aayog as a platform for taking states' support while preparing some new scheme of national importance or making changes in the 'sharing pattern and objectives' of the already running schemes. Also, the annual work plan for implementation of the centrally-sponsored schemes should be left at disposal of the

Discussing the 'MenuApproach' Smt. Raje said that all the states should be given the right of selecting the centrally-sponsored schemes as per their interests, so that these could resolves their own issues of development. She suggested for dividing the scheme formation into three categories for some particular regions. One category should be of the schemes for all the states; while the second should be schemes for groups of states like the North-eastern states. A third category could be of the schemes specially designed for a particular state like Ladali or Lakshmi Yojana. In the meeting, the CM argued for the centre and the states coming together for development. She also suggested for ending the distinction between 'plan' and 'non-plan' heads of budget allocation. Smt. Raje said that the NITI Aayog should work as a knowledge repository where a huge database is developed for the states and this commission should encourage healthy competition between the states without any par-

#### Probe Ordered Into Financial Irregularities at **Jodhpur Varsity**

Jodhpur: The state government has ordered the Jodhpur divisional commissioner to initiate an inquiry into the alleged financial irregularities committed by the vice-chancellor and the registrar of Dr. Sarvepalli Radhakrishanan Rajasthan Avurved University in Jodhpur.

On April 10 the ordered was issued by the principal secretary of ayurved and indian medical department for inquiry after the finance (audit) department.

The complaint says the state government had to suffer due to the loss of interest on the balance in the public deposit account (as banks do not provide interest on current account balances).

The estimated loss to the government and the name of the private bank are unknown as the case is being probed by the governmentnt.

#### District court quash collector's 'No petrol-no helmet' order in Udaipur

Udaipur: The district and but it is clearly stated that session court on Friday. quashed an order passed by the district magistrate that imposed restrictions on fuel stations on selling petrol to twowheeler drivers without helmet. Calling it an act beyond the powers of collector to bind the fuel station owners to make public adhere to the provisions of the motor vehicle act, the order was dismissed.

Erstwhile collector Ashutosh AT Pednekar had on April 16, by evoking section 133 of the CRPC imposed the ban, creating a stir among the civil society that raised stern objections against the rule which was claimed to be autocratic and unconstitutional. Protests and rally had followed further making things complicated for the petrol pump owners who expressed inability to abide by the rule. A review petition was filed by activist Trilok Mehta, who held in his plea that Section 133 is

related to removal of nuisance

unless there is imminent danger to the health of physical comfort of the community or conduct of the trade and occupation is in fact dangerous to people, an order under the section cannot be passed. Pronouncing the verdict,

Honorable Justice Pankaj Bhandari, held that helmets may be compulsory for vehicles in motion but at fuel stations, vehicles are stationary and hence there is no threat to life to those ones not wearing it. The judge also said in his decision that fuel stations are situated in private land not public place and petrol pump owners could not be bound to make people adhere to the provisions of the Motor Vehicle Act. "The court also held that sale of petrol to two wheeler riders without helmet cannot be defined as public nuisance and section 133 is essentially related to removal of nuisance" said Sunderlal Mandawat, the pleader.

A district complaint committee empowered to hear such complaints, has submitted its report finding the charges to be true.
