## Nimbaheda girl refuse to marry ...

Udaipur: Setting a precedent by raising her voice against social evil of child marriage, a 20-year-old girl from a small village in Chittorgarh district not only publicly refused to marry her childhood fiancé but took a step ahead by reqistering a criminal case against him when the later tried to forcefully take her away from home. The girl who appeared before an ACJM court at Nimbaheda recently, said in her plea that police took no action against the culprits when she registered her complaint at the station. At the girl's complaint, the court has ordered the concerned station to lodge a case and

investigate the matter. Sapna, daughter of Nandlal Gayri, a resident of Gadola village under Nimbahera Kotwali police station held in her plaint that she was engaged to one Lalaram, son of Mohanram Gayri, resident of Sadarya village under Jawad police station in Madhya Pradesh, 15 years ago. The girl said, the alliance had been fixed by the family members when she had been too small to realize, however, after growing up, she came to know that her fiancé was a man of lose character. She refused to marry him which angered the boy. Lalaram barged into her home with seven men of his villages on May 12 and tried to forcefully take her away. Family members intervened as the girl screamed for help and dissuaded him. But, Lalaram who felt humiliated before the community after being rejected by a girl, threatened Sapna of dire consequences if she didn't agree to marry him.

He said he would abduct her

some or the other day if she remains adamant to break the ties. The girl who was too shocked after the incident, however, mustered courage enough to voice her complaint to the authorities. She even made complaints to the MP police urging to initiate action against the culprits who tried to abduct from her house, but no action was taken. Meanwhile Borai Singh, the circle inspector of Nimbahera Kotwali thana said that the case had been already registered and an investigation is ongoing and if the allegations by the girl are found to be true, the culprits would soon be arrested.

## Dr. Jyoti Kiran appointed as Chairperson

Jaipur: State government has notified constitution of the State Finance Commission. Dr. Jyoti Kiran will chair the Commission and retired IAS Shri S.C. Derashri will be the full-time Member Secretary. The Chairperson will be given status of the Minister of State. State Finance Commission will give recommendations in regard to financial management and allocation of funds to the Panchayati Raj Insitutions (PRIs) and the Municipalities. It will review the status of finances of the Panchayats and Municipalities and recommend for improvement. The commission will also give recommendations in regard to collection of revenue in the form of taxes, duties, fee etc. in the respective Panchavat or Municipal regions. As per notification, the Commission shall cover a period of five years commencing from April 1, 2015 and submit its report by November 30, 2015. Chairperson of the State Finance Commission Dr. Jyoti Kiran has a good knowledge of economic affairs and she is a doctorate in Economics subject.

they develop the habit of consuming such stuff and end up on receiv-

According to the experts, consumption of tobacco reduces six to eight years of one's life. In Rajasthan only 32 percent adults (50 percent men and 12 percent women) consume tobacco or tobacco products. People from rural areas are more in number when it comes to overall consumption. In a shocking revelation through a report in 2010, it was learnt that 50 percent children start eating tobacco before they turn adult.

## Ustad get live bait to feast on at Sajjangarh park

to not leave T-24 even after 10 days of his relocation from the lavish wilds of Ranthambore to a comparatively small 10,000 sqft enclosure at the Sajjangarh Biological Park here. The 250 kilograms weighing magestic big cat 'Ustad' is under scanner again, however, this time for no fault of his own. Questions are being raised at the park authorities for offering live bait to the majestic cat, something which is strictly prohibited in the zoos. Not any outsider, but one of the member of the high power committee which was framed to monitor T-24's behavior at the park, claimed that since tiger wasn't eating the meat given to him, a young buffalo was tied in the enclosure on the second day of his arrival at the park. However, authorities said the tiger is being given only what that has been prescribed by the medical experts to keep him

Udaipur: Controversies seem healthy and living. "There is a board of experts who is advising us on his diet and we are doing accordingly" Rahul Bhatnagar, chief conservator of forest (wild life) said.

" Using live cattle as bait for protected animals is prohibited under India's wildlife laws as there are chances of outspread of bacterial infection in the enclosure which could be fatal" claimed Dr Raja Tehsin, former wild life warden and member of the committee. "I had gone near his enclosure to observe him where I saw bones and intestine left overs of the bait tied in his cage. It was smelling really bad and I even asked them who would do the cleaning here" the veteran expert asserted. "Long back in the 80's a female panther was brought in the Udaipur zoo from the jungle which didn't eat for many days. Then on my suggestion, the animal was given glucose mixed



water on which it easily survived" reminisced Tehsin. Same technique was also applied on Ustad who was also given glucose mix water to compensate for diet loss, he said. In forests, hunting is routine for the wild animals without fear of infection since scavenger animals like hyenas, wolves and jackals feed on the left over prey. However, as cleaning is not possible in enclosures at zoos, the animals are given slaughtered meat.

T-24 who was shifted on May 16 from Ranthambore to the bio-

logical park here, had not eaten a morsel of food which had panicked the forest officials. " T24 being a wild animal wasnt habitual of eating dead meat and the authorities were perhaps worried for its well being and to ensure that he eats something, live bait was given" sources informed. It was also revealed that the bait was tied to his cage and after the animal ate it, the remains were pulled out through the string it had been tied with. Another explanation offered on the live bait is that the tiger may become too lazy to hunt if he conditions himself to the readily available food. If he is required to be shifted back to Ranthambore on court orders at any stage later on, his survival would get difficult as he would not be keen in finding a prey. In such a case, probable threat from villagers like lacing poison in meat to kill him fearing as man eater cannot be denied.

### T-24 is healthy, adapting to new environment: Rahul Bhatanager

T-24-3Meanwhile, authorities released visual clips of T24 tossing around his enclosure in the park. With animal lovers calling at the park continuously from various parts of the country, inquiring about his wellness, forest department gave a press briefing on Tuesday to put an end at all controversies. "T24 is perfectly well, he is eating and moving normally. He is adapting to the new environment "said CCF Rahul Bhatnagar. CCTV cameras have been installed at vantage points to monitor T24's many moods. "The footage shows Ustad lying under a tree during day and pacing up and down, usually sitting next to his cell's wall, 30 metres from the opposite cell, occupied by a tigress called Damini," Dr. T. Mohanraj, the DCF said. When Ustad is released from his cell in the larger open area of the enclosure, Damini is held back, and vice-a-versa, to avoid a confrontation. Park officials joke that when Ustad growls, the tigress growls back and the two could make a romantic pair, making him feel less homesick.
