# Maggi Millions of Indians face controversy: danger of lead poisoning Millions of Indians face

Having been lucky enough to eat fresh, home-cooked food for most of my life, I've never taken to Maggi noodles, which is why the accusations against Nestlé's top Indian brand made no personal impact on me. Packs of instant noodles examined by a Calcutta lab at the instance of the Uttar Pradesh Food Safety and Drug Administration apparently exceeded permissible levels of lead and contained monosodium glutamate unmentioned in the ingredients' list. It seems to me the case is another instance of bureaucratic overreach. To begin with, the scaremongering about monosodium glutamate is bereft of evidence, as this article in the New Scientist makes clear. (The piece also covers gluten "allergies", for good measure.)

Lead is a different matter. It's extremely dangerous, even fatal if ingested in large enough quantities. The permissible limit in this type of Indian food is 2.5 parts per million and the examined batch of Maggi noodles is said to have had seven times that much. Nestlé's own studies provided contradictory figures, which is hardly surprising. While I don't trust Nestle, I trust India's food inspectors and government labs even less. Why go after trace quantities of lead in noodles when our air and water are poisonous, and noise levels orders of magnitude above the recommended maximum? How many food stalls, or even restaurants, in India would remain

open if they had to adhere to prescribed hygiene standards? And how many have been shut down by the food safety chaps?

#### The foreign hand

The Nestle case is like jailing a man for fixing a grille on the windows of his home (which happens to be an illegal act), while allowing his neighbors to construct unauthorized high rises. Companies like Johnson & Johnson, Pepsi, Cadbury, and Nestle, all targeted in the past for sidestepping safety, appear to be held to a more exacting norm than Indian firms, and certainly cottage industries. Such double standards would make sense if our immune systems could tell multinational products from swadeshi ones, but unfortunately, they have yet to evolve that sensitivity.

The controversy around Maggi noodles, under scrutiny for high content of lead and mono-sodium glutamate or MSG (a taste enhancer), has led to a sharp correction in Nestle India shares. Four states - Delhi, Gujarat, J&K and Uttarakhand - have banned Maggi for varying periods; many others have announced tests of Maggi noodles. Since May 28, Nestle shares are down nearly 15 per cent from Rs 7,038.65 to Rs 6.010.80. The selloff has wiped out nearly Rs 10,000 crore from Nestlé's market capitalization. On Thursday, Nestle shares dropped below Rs 6.000 for the first time since December 2014.

Maggi is a big revenue gener-



ator for Nestle India, which reported a net profit of Rs 1,185 crore on sales of Rs 9,800 crore in 2014 calendar year. Maggi contributes around 22-25 per cent to Nestlé's top line and 30 per cent to the company's profitability, according to Kotak Institutional Equities.

A number of brokerages have started downgrading the stock. Barclays, which has a "underweight" call on Nestle, on Thursday cut the target price on Nestle shares from Rs 5,593 to Rs 5,149 citing high valuations. ICICI Direct, which has a "hold" rating on Nestle, cut its target price by 12.5 per cent to Rs 6,039. The brokerage expects sales from prepared dishes segment to take a beating in the next few quarters; Nestle will have to increase its advertising and promotional spend significantly to neutralize the impact of this controversy, it added.

"Nestlé's brand equity has taken a hit in the wake of this controversy as Maggi noodles are largely considered a staple snack for children," ICICI Direct said. Interesting, Maggi was adjudged the most powerful brand in India by WPP Milward Brown, according to Nestlé's 2014 annual report. Kotak Institutional Equities also cut its target price on Nestle from Rs 6,200 to Rs 5,800. The brokerage has a "reduce" rating in the stock. "We believe this event should make investors question the 'quality premium' attached to the company... A slip-up on safety aspects (if true) and poor PR management of the event raise valid questions on the premium," Kotak said. Phillip Capital downgraded Nestle to "sell" with a target price of Rs 5,110. "If

Actors Madhuri Dixit, Amitabh Bachchan and Preity Zinta could land in trouble if advertisements for Maggi noodles featuring them are found to be misleading, says the consumer affairs ministry. Maggi brand ambassadors, including Bollywood star Madhuri Dixit, were "warned of action" by the government if their advertisements for Nestle's popular noodle product were found to be misleading. However, Amitabh Bachchan has been quoted in a report as saying that he has not received any notice from the government over endorsing Maggi noodles. He says that he will fully cooperate with the law and adds that he had stopped endorsing the instant noodles' brand two years ago. According to reports, the Bihar court has ordered the police to lodge an FIR against Bollywood actors Amitabh Bachchan, Madhuri Dixit and Preity Zinta, who are the brand ambassadors of Nestle India, following a complaint filed by a lawyer alleging that he fell ill after eating Maggi. Reportedly, the court has ordered the police to file an FIR against the actors under various section of IPC (Indian Penal Code) that includes IPC 420 for cheating consumers. Also included are Section 270 for malignant act likely to spread infection of disease dangerous to life and Section 273 for sale of nox-

#### What rules govern "instant noodles" (such as Maggi) under FSSAI?

According to Food Safety and Standards Rules, 2011, MSG, a "flavor enhancer", should not be added to food for infants below 12 months. MSG is not permitted in over 50 items, including "Pastas and noodles (only dried products)", but is allowed in the seasoning used for noodles and pastas. Under Food Safety and Standards (Contaminants, Toxins and Residues) Regulations, 2011, permissible levels of lead range from 0.2 parts per million in infant milk substitute and infant foods to 10 ppm in categories like baking powder, tea, dehydrated onions, dried herbs and spices flavorings. For instant noodles included in the "foods not specified category", the permitted level of lead is 2.5 ppm. Instant noodles like Maggi are identified under food category code 6.4.3, which includes "pre-cooked pastas and noodles and like products" that are "pre-gelatinized, heated and dried prior to sale". These categories of food are governed by Codex international standard 249, standards of food safety recognized by WHO. The masala used in these noodles is identified in code 12.2, which includes herbs, spices, masalas, seasonings, and condiments (e.g., seasoning for instant noodles), where the use is "intended to enhance the aroma and taste of food", according to FSSAI regulations.
