25 Lacs sanctioned to Seva Bharti Hospital

Gitanjali docs achieve another milestone in surgery

Udaipur : Gitanjali has become the first such hospital where heart and brain angioplasty was carried out together. A 61 years old patient was treated by Dr. CP Purohit and Harish Sanadhya of cardiac department of Gitanjali hospital of Udaipur. Doctor duo treated problem in neck's artery and blockage in stent of the heart simultaneously and successfully using the angioplasty. Dr. Sanadhya later told that the patient was admitted to the intensive care unit of hospital where initial investigations suggested that his heart was weak. ECG reported some past heart attacks too. After angiography of artery of neck that supplies blood to brain, it was detected that his artery of left side of the neck was totally blocked and the right side artery was also blocked up to 90 percent. This was not all. The patient had installed a stent in his heart two years ago which was also 90 percent blocked. The operation was successful and now the patient is alright. With arteries, the stent blockage was also cleared successfully. Doctors claimed that this one first such case of its kind in Udaipur district.

financial fine. He also said that a undisclosed property bill is also set to be approved in Lok Sabha by next month.
