also has a deep passion for sports and is the Vice President of the Badminton Association of India and is associated with Sports Associations.

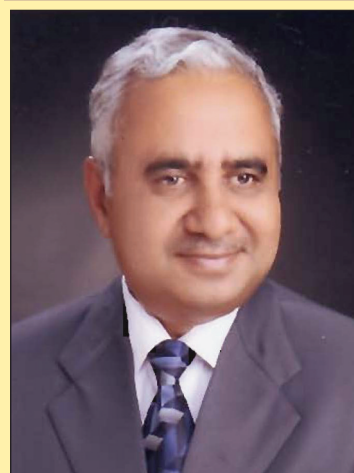

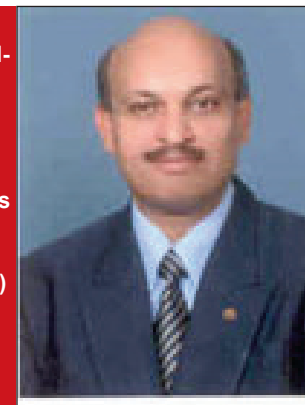
