INS Tarkash at St. Petersburg, Russia

Towards bolstering the robust ties between Russia and India and in recognition of the 'Special and Privileged Strategic Partnership' between the two countries. Indian Naval Ship Tarkash arrived at St. Petersburg, Russia today, on 25 July 2019 to participate in The Russian Navy Day Parade. The ship was welcomed into harbour by officials from the Russian Navy with a live performance by the Russian Naval Band as a part of the Welcome Ceremony.

The Indian Navy is being represented at the Russian Navy Day Parade 2019, by a delegation led by Vice Admiral Ajit Kumar P, Flag Officer Commanding-in-Chief, Western Naval Command and INS Tarkash. In addition to attending the Navy Day Parade, the Flag Officer would also call on the Commanderin-Chief of the Russian Navy to review Navy to Navy cooperation and explore new avenues for collaboration.

INS Tarkash will form part of the mobile column for the review by the President of the Russian Federation. During its stay in harbour, the ship will be berthed at Lt Schmidt Embankment and remain open for visitors on 26 and 27 July 2019. The ships crew would also have professional interactions with the Russian Navy towards enhancing co-operation between the two forces.

INS Tarkash, commanded by Captain SathishVasudev, is the second ship of the state-of-the-art Teg Class Stealth Frigates (P1135.6), built by Yantar Shipyard at Kaliningrad, Russia. It is equipped with a versatile range of weapons and sensors and manned by a highly motivated crew of over 250 personnel including 30 Officers. It incorporates the latest stealth features such as reduced radar, infra-red, acoustic and magnetic signatures, thus making it difficult to detect at sea.

HDFC: FINANCIAL RESULTS FOR THE QUARTER ENDED **JUNE 30, 2019**

Udaipur: The Board of Directors of HDFC Bank Limited approved the Bank's (Indian GAAP) results for the guarter ended June 30, 2019, at their meeting held in Mumbai on Saturday, July 20, 2019. The accounts have been subjected to a 'Limited Review' by the statutory auditors of the Bank.

Profit & Loss Account: Quarter ended June 30, 2019

The Bank's total income for the quarter ended June 30, 2019 at 32,361.8 croregrew by 22.7% from 26,367.0crore for the quarter ended June 30, 2018. Net revenues (net interest income plus other income) increased by 24.8% to `18,264.5crore for the quarter ended June 30, 2019 from 14,631.6crore in the corresponding quarter of the previous year. Net interest income (interest earned less interest expended) for the quarter ended June 30, 2019 grew by 22.9% to `13,294.3crore, from `10,813.6crore for the quarter ended June 30, 2018, driven by asset growth and a core net interest margin for the quarter of 4.3%

Other income (non-interest revenue) at `4,970.3crore was 27.2% of the net revenues for the quarter ended June 30, 2019 and grew by 30.2% over `3,818.1crore in the corresponding quarter ended June 30, 2018. The four components of other income for the quarter ended June 30, 2019 were fees & commissions of '3,551.6crore (' 3,171.0crore in the corresponding quarter of the previous year), foreign exchange & derivatives revenue of `576.7crore (` 499.6crore for the corresponding quarter of the previous year), gain on revaluation / sale of investments of `212.0crore (loss of `283.2crore in the corresponding quarter of the previous year) and miscellaneous income, including recoveries and dividend, of '630.0crore (' 430.7 crore for the corresponding quarter of the previous year)

Operating expenses for the quarter ended June 30, 2019 were `7,117.3crore, an increase of 18.9% over `5,983.9crore during the corresponding quarter of the previous year. The core cost-to-income ratio for the quarter was at 39.4% as against 40.1% for the corresponding quarter ended June 30, 2018.

Provisions and contingencies for the quarter ended June 30, 2019 were `2,613.7 crore as against `1,629.4 crore for the quarter ended June 30, 2018. The key components therein for the quarter ended June 30, 2019 were specific loan loss and contingent provisions of `2,413.5crore (as against ` 1,432.2 crore for the corresponding quarter of the previous year) and general provisions `200.2crore (as against `183.2crore for the corresponding quarter of the previous year). General provisions include additional provisions of `85.9 crore for standard advances to the NBFC / HFC sector. Profit before tax (PBT) for the guarter ended June 30, 2019 was up 21.6% to `8,533.6crore. After providing `2,965.4crore for taxation, the Bank earned a net profit of `5,568.2 crore, an increase of 21.0% over the guarter ended June 30, 2018.

NETWORK

As of June 30, 2019, the Bank's distribution network was at 5,130 banking outlets and 13,395 ATMs across 2,764 cities / towns as against 4,804 banking outlets and 12,808 ATMs across 2,700 cities / towns as of June 30, 2018. Of the total banking outlets, 53% are in semi-urban and rural areas. Number of employees were at 104,154 as of June 30, 2019 (as against 89,550 as of June 30, 2018).

ASSET QUALITY

Gross non-performing assets were at 1.40% of gross advances as on June 30, 2019 (1.17% excluding NPAs in the agricultural segment) as against 1.33% as on June 30, 2018 (1.09% excludingNPAs in the agricultural segment). Net nonperforming assets were at 0.4% of net advances as on June 30, 2019. The Bank held floating provisions of `1,451 crore as on June 30, 2019. Total provisions (comprising specific provisions, general provisions and floating provisions) were 115% of the gross non-performing loans as on June 30, 2019.

The consolidated net profit for the quarter ended June 30, 2019 was `5,676crore, up 18.0%, over the quarter ended June 30, 2018. Consolidated advances grew by 17.2% from `751,386crore as on June 30, 2018 to `880,939crore as on June 30, 2019.
