GOVT SCRAPS SPECIAL STATUS FOR J&K

strip Jammu and Kashmir of its special status under the Constitution was cleared by the RajvaSabha on Monday, eight hours after home minister Amit Shah introduced a resolution to cancel the provision that had continued to be part of the Constitution

The RajyaSabha also cleared a bill to divide the state into two union territories, one for Ladakh and the second for Jammu and Srinagar regions. Both would be administered by the central government through a Lt-governor. A union territory is an administrative division governed directly by the central government.

Aresolution to abrogate the special status was passed by the RajyaSabha with 125 votes in favour, and 61 against. The bill to divide Jammu and Kashmir was passed by a voice vote.

Shah, who piloted the bill through the upper house where the ruling National Democratic Alliance (NDA) doesn't have a clear majority, triggered an

The government also imposed a security lockdown on Kashmir after deploying tens of thousands of troops in the past week.

The communication network in the Valley - mobile, fixed line and internet - was shut down ahead of the government's announcement while key officials have been given satellite phones to stay in touch.

With the Centre's move, the union territory of Jammu and Kashmir will have a Lt Governor and the strength of the Assembly will be 107, which will be further enhanced to 114 after a delimitation exercise is

carried out.

The present strength of the assembly is 87, which includes four seats of the Ladakh region. Ladakh will now become a separate UT, but without a legislature. Twenty-four seats of the assembly continue to remain vacant as they fall in the area of Pakistan-occupied Kashmir

Shah, however, said that the Centre was open to making Jammu and Kashmir a state once the situation normalized. "I want to assure the House that whenever normal situation returns, right time comes, we have no objection in making it a state," he said.

The home minister also brushed aside fears that there would be violence in Kashmir as he stood up to respond to the debate, saving "nothing of the sort will happen".

The announcement sparked chaotic scenes in Parliament, with opposition parties describing it as a "catastrophic step". They called the move to abrogate Article 370 an aggression against the people of the state.

Leader of Opposition in RajyaSabha, GhulamNabi Azad said: "In my political life, I had never even imagined that the state which is India's crown, one day that head will be chopped off"

Parliamentarians from the Congress, TMC and DMK later walked out of LokSabha in protest as prime minister attended the session. The Left parties also staged a demonstration at JantarMantar in New Delhi, slamming the NarendraModi-led government for scrapping Article 370 and demanding that the earlier status of the state be restored.

Death penalty for hate crimes in state, assembly passes bill



Jaipur: The Rajasthan assembly passed a bill on Monday in which death penalhas been proposed for hate crimes against couples in the name of honor and tradition. The bill, The Rajasthan Prohibition of Interference with the Freedom of Matrimonial Alliances in the Name of Honor and Tradition Bill, 2019, was tabled in the Assembly on July 30 by law minister Shanti Dhariwal. It was passed after discussion on Monday. Rajasthan is the first state in India to have a special law to deal with hate crime against couples.

The bill even provides punishment for holding assemblies to condemn intercaste, inter-community marriages in the name of family honor.

Though the punishment for murder in rarest of rare murder cases under the Indian Penal Code is also death penalty, the bill said a special law for such hate crimes would act as a deterrent as it has severe punishment for such acts of violence and criminal intimidation and will prevent caste and community assemblies that take place to condemn such marriages.

The bill states that "whoever causes death of a couple or either of them on the basis that marriage of such couple has dishonored, or brought disrepute to the caste, community or family shall be punished with death, or with imprisonment for life, which shall mean imprisonment for the remainder of that person's natural life, and with fine which may extend to five lakh rupees." If cases of grievous hurt to a couple or either of them, the bill prescribes rigor-

ous imprisonment for 10 years which may be extended to life imprisonment and a fine of Rs3 lakh. For simple hurt, the punished proposed is jail for three to five vears and a fine of Rs2 lakh.

For participating in a gathering to condemn a marriage claiming it has dishonored the caste or community or tradition or brought disrepute, a person or persons can be sent to jail for six months to five years and fined Rs1 lakh. The bill empowers the sub-divisional magistrate or district magistrate to prevent such assemblies and take steps to ensure safety of the couple.

The bill also covers threat to the couple by prescribing punishment of three to five years and a fine of Rs 2 lakh. If threat is to cause death or grievous hurt, the imprisonment will be of seven years, the bill says.
