New Delhi: Nowadays, people need access to different types of loans for various requirements. Having at least a couple of credit cards is also considered a standard norm to facilitate shopping and the purchase of goods that would otherwise be deferred.

In such a scenario, it is important to ensure you have a good credit score since the easy availability of personal, consumer and other loans as well as access to credit cards is contingent on this. Today, credit scores can be checked for free online. Therefore. checking your credit score regularly may be necessary to ensure it always remains within healthy levels that allow you access to loans and cards. Understanding the Credit

check your credit score free online. While some readers could be aware of what credit scores are all about, a few may not understand the concept properly. It's essential to be aware of your credit score because the terms and conditions of the loans you avail of will depend on this.

A healthy credit score ensures loans are available at more benign terms with lower interest rates, which will help save some of your money. An unhealthy score would mean your loan or credit card application is rejected or approved on not-so-favourable terms.

Before knowing how to check your credit score online, let's understand the concept first. The credit score of borrowers ranges between 300 and 900. In India, there are four credit information companies

or credit bureaus, TransUnion CIBIL, Experian, Equifax and CRIF High Mark, whose credit scores are popular with both borrowers and lenders. Furthermore, fintech credit providers like Clix Capital also provide individuals with their free credit scores. The credit score tells banks or lenders about your creditworthiness as a borrower. Credits scores that are at least 750 or above are deemed to be good. This

score is based on your credit history, which is contingent on making timely repayments, the amount and number of times you have borrowed, the type of loans you have availed to date and other relevant factors. Timely repayments concern EMIs on loans as well as credit card bills, among others.

The specific score is assigned to people based on their data mentioned in a Credit Information Report (CIR), For detailed information of consumers' credit/loan history, including identity information, loans, credit cards, credit accounts, payments and recent enquiries.

Experian updates its CIR every month, based on the consumer credit information it receives from its member banks and other institutions once a month. This data also considers the number of requests you have made for different loans or applied for credit cards. Lenders may seek such information, including your credit score, before approving any loan or card. Such requests from lenders are termed "hard inquiries". Ahigher number of hard inquiries can lower your credit score and the chances of your loan or card application being approved

a greater risk of default.

Additionally, the percentage of credit limit utilised on the score. Clix advises its customers to only utilise around 30% to 40% of their credit card keep the credit score high. Clix customers are also cautioned against having multiple credit cards or outstanding unsecured loans as these can impact their credit score.

Modalities to Check Credit Scores Free

Finally, we come to the question of how to check your credit score online, free. One of the popular ways is to visit the Experian website or that of another credit bureau and check your free credit report. You will need to enter the necessary details, such as your

mobile number. Once this is done, you will receive an OTP on your mobile to verify your number. Thereafter, you can credit card affects your credit access your free Experian credit score and credit report.

Typically, more than 80% of all new loans will be offered spending limit each month to to customers with a credit score above 750. Considering the importance of an individual's credit report in availing financial products, the RBI has mandated that India's four major credit information bureaus provide individuals with one free credit report once a year, on request.

will be mailed to you within 24 hours. After you receive your credit report, check it carefully to ascertain all details are correct. This is necessary to safeguard against any fraud or identity theft. Moreover, in case there are errors, you can rectify them by informing your bank or the credit agency.

It is possible that after receiving the annual free credit report, you may need to check your credit score once again later in the same year. If so, you can then subscribe to a paid access plan from any of these credit bureaus. Or you could visit the Clix Capital website for your free credit score.

Remember, regularly monitoring your credit score will help you take corrective steps in case of any issue. Obtaining a loan on favourable terms will then make your life much eas-

All he ever knew before then was working with his hands to put food on the table. At the tender age of 13. and like most other small town Indian boys, he already knew what it meant to carry an entire family on his shoulders.

His voice and strong positive energy comes across as inspiring, motivating and energising, the kind anyone wants to listen to first thing in the morning. He still remembers his live broadcast from the 26/11 attacks where he was on air giving live and important updates during a trying period. Parikshit was also on ground doing a live coverage during the Navratri stampede; still regarded as one of Jodhpur's biggest tragedy.

After doing radio in India for half a decade, he moved to Dubai in 2010 where he now hosts a popular breakfast show on UAE's No.1 Bollywood Music Station. He's a complete Indian abroad - on and off air - exploring as many places and people as he possibly can. His show is one of the most popular in Dubai and even beyond, not just among the Indian community, but also among non-Indians. No wonder he's been widely recognised by reputable organisations over the years. One noteworthy achievement was getting on the Limca Book of World Records for hosting the longest live radio ever - a whopping 195 hours. HDFC Bank net profit up 17.6 percent

Udaipur: The Board of Directors of HDFC Bank Limited approved the Bank's (Indian GAAP) results for the quarter and half year ended September 30, 2021, at its meeting held in Mumbai on Saturday, October 16, 2021. The accounts have been subjected to an audit by the statutory auditors of the Bank.

The Bank's net revenues (net interest income plus other income) increased by 14.7%

to Rs. 25,085.2 crore for the quarter ended September 30, 2021 from Rs. 21,868.8 crore for the quarter ended September 30, 2020.

Net interest income (interest earned less interest expended) for the quarter ended September 30, 2021 grew by 12.1% to Rs. 17,684.4 crore from Rs. 15,776.4 crore for the quarter ended September 30, 2020. Advances grew at 15.5% reaching new heights driven through relationship management, digital offering and breadth of products. Core net interest margin was at 4.1%

Balance Sheet: As of September 30, 2021 Total balance sheet size as of September 30, 2021 was Rs. 1,844,845 crore as against Rs.1,609,428 crore as of September 30, 2020, a growth of 14.6%.

Total deposits as of September 30, 2021 were Rs. 1,406,343 crore, an increase of 14.4% over September 30, 2020. CASA deposits grew by 28.7% with savings account deposits at Rs. 452,381 crore and current account deposits at Rs. 205,851 crore. Jaipur: The Deputy Chairman of the Niti Ayog, Rajiv Kumar on Saturday visited the Jaipur Foot centre of the Bhagwan Mahaveer Viklang Sahayata Samiti.(BMVSS) Rajiv Kumar inspected the manufacturing process of the Jaipur Foot and also met the beneficiaries drawn from different parts of the country. Niti Ayog is a public policy think tank of the Union government headed by the Prime Minister, Narendra Modi with Rajiv Kumar as the deputy chairman .Niti Ayog has been set up in place of Planning Commission.



Rajiv Kumar and his wife Vinita Narayan were received by DR Mehta, the founder and Chief patron of the Bhagwan Mahaveer Viklang Sahayata Samity, the parent body of the Jaipur Foot along with the Executive President SS Bhandari, honorary secretary, Dr Deependra Mehta, Chief Executive Officer, R K Agarwal, Chief Technical Director, Dr M K Mathur, technical Consultant Dr Pooja Mukul, Dr PK Jain and others

DR Mehta gave a presentation on the working of the Jaipur Foot organisation and informed the deputy Chairman of the Niti Ayog that about 20 lakh persons have been so far rehabilitated by providing artificial limbs, callipers, and other aids and appliances in India and abroad. He said the Jaipur Foot because of its high technical excellence and low cost has proved to be a boon for the disabled as it is multifunctional and the disabled could walk, run and do all job and even ride a bicycle.

D R Mehta informed the deputy chairman that for the last about 10 days, BMVSS in collaboration with the Indian army has held six on-the-spot limb fitment camps at places like Kupwara, Uri, Badgam in Kashmir valley, all known for the high security risk. In these camps about a thousand Kashmiri disabled have been rehabilitated. He also told him that the BMVSS would hold similar camps in Sukhma and other dangerous Naxal area of Chhatisgarh. During an informal interaction with the members of ther executive committee and others Rajiv Kumar evinced keen interest in the prosthetic which has earned enormous goodwill among the disabled of both India abroad. Satish Mehta, Indian's former ambassador ,the honorary international affairs Director of the BMVSS, said the Jaipur foot has rehabilitated over 35,000 disabled of 35 countries by holding special camps such as Afghanistan, Pakistan, Syria, Iraq, Vietnam, Myanmar, Egypt etc. This figure includes 7000 disabled rehabilitated under the Ministry of External Affairs (MEA), India ,under its "India For Humanity" Programme. This programme was launched by the ministry of external affairs to commemorate the 150th birth anniversary of Mahatma Gandhi and is still continued as a goodwill gesture to benefit the disabled of the poor nations. Rajiv Kumar and his wife Vinita Shankar, who met the beneficiaries drawn from various countries and inquired as to how the artificial limb has changed their lives. He lauded the role played by the Jaipur Foot which has emerged as the world's largest organisation for the rehabilitation of the disabled that has so far rehabilitated about 20 lakh disabled in India.
