Dr. K Madan Gopal said that currently our 8.6% population is old age which will be 12% in 2030 and 20% by 2050. He also said that life after 50 comes with lot of social, economic & mental health diffi-

He also highlighted about elderly people living in rural areas who do not have the Digital Healthcare Access. Dr. Gopal also mentioned that during second wave of covid-19 the demand for Telemedicine

& Tele health has been increased drastically which has also made life easier for the patients specially living in the rural areas. There's an utmost need for creating awareness about the availability of digital Healthcare facilities available for the elderly in the rural areas and we can educate them about it.

Dr. Gopal also talked about

various initiatives taken by Niti Aayog for the elderly people in India and about National Health Mission as it provides opportunity for telemedicine consultation and has a wide network of diagnostic labs and provide primary care to all the people. Dr. Gopal also urged everyone to come forward and work together to make a better digital care for the elderly people in India. He further added to look for the opportunity to utilize the potential of elders which they have gathered during their productive life

& delegates, Dr. Sameer Gupta

said that COVID-19 is changing older people's daily routines, the care and support they receive, their ability to stay socially connected and how they are perceived. He further added that older people are being challenged by requirements to spend more time at home, lack of physical contact with other family members, friends and colleagues, temporary cessation of employment and other activities; and anxiety and fear of illness and death - their own and others. It is therefore important that we create opportunities to foster

healthy ageing during the pandemic. Dr. Sameer also said that Digital Equity is a condition in which all individuals and communities have the information technology capacity needed for full participation in our society, democracy and economy including older persons - to ensure new opportunities and benefits are avail-

tioning about the work done by HelpAge India for elderly, Mr. Rohit

Prasad mentioned about multiple determinants of ageing and health. Mr. Rohit said that Covid has disproportionately affected the elders livelihoods, income, loneliness and digital divide led to elders struggling

while mentioning about the way forward, Mr Rohit said that there is an urgent need to enhance the digital literacy / skills of elderly to have transformational impact on their lives. There is also a need to develop elder specific and elder sensitive solutions which can be called as age friendly digital solutions and finally the focus should be on research and data for elderly with age disaggregated data and analysis for better insights & evi-

dence into problems to solve. Talking about the senior care. Dr. Ipsito Chakravarty said that it is not the "lifespan" but the "healthspan" that matters; it is not the Quality of Life (QoL) but the Quality of Experience (QoE) that matters; it is not the "object" but the "subject" that matters. Dr. Ipsito further mentioned about Elderlyfriendly interfaces which are very much important for Digital

## Sonepat Kundali Scam is Worth More Than One **Hundred & Fifty crores: Sandhu**

### Case Padding Ray of hope of Retired **RLy Employees**

IRWO's Scam which was taken out of Seventy-Six crores is due to from rate gimmicks of Indian railway welfare origination which was told earlier it has happened due to the way the plan was changed later. While all other types of frauds are added then the amount of housing scheme of Sonipat Kundli Railway employees will be More than Rs 150 crores it was told by Shri RS Sandhu, Chairman, Rail Vihar Sonepat Members Welfare Association.

He said that the location in the Sonepat Kundli project was Never disclosed by Indian Railway Welfare Origination correctly and always tried to mislead by telling it according to the landmark. IRWO showed the dream of building the Sonepat Kundli project on the Delhi border. The land was purchased from a private builder in Raipur Village Sector 10 Sonepat 18 km from Kundli. where there is no road to come. In this way IRWO was the first to commit a land purchase scam which cannot even be estimated. the officers and brokers involved in the purchase of this land if they are closely interrogated then the truth can come out. IRWO has taken a separate plot for the type four category and a different plot for type three and type two flats. the road was left in the middle which increases the cost burden. Haryana Government and UP Government are providing big plots for group housing for the employees bur irwo officers don't want to work with clean

Sandhu says that land biggest Scam was occurs in sonipat kundli project by IRWO officers.

flats was increased by digging the basement for 625 parking. due to which the cast of the flats was increased more. The soil which came out from the excavation of the land was sold and cheated of Rs 10 corer and no information was given. The cost of digging and the cost of its construction has also fallen on the people who have bought flats there. Whereas IRWO wanted all the retired and serving employees who were willing to buy flats under this scheme to talk to them again and again and tell them every calculation this has not been done to date

Where is the justice for the buyers of the first and second phases. where different rates have been fixed in one Building. while IRWO started construction together they did not make any separate arrangement for them. all the allotters' have under the same plan? If the total Building is constructed how can the different cost prices come out in Phase I and

The IWRO has burdened their mistake on the retired and serving railway employees. When fewer applicants came to IRWO a conspiracy was hatched to rob the employees by increasing the cost of those flats by making them the second phase. The working of IRWO is not transparent. Even today, many flats have not been sold in the Sonepat Kundli, this is also a scam of IRWO. whose financial burden has already been put by IRWO on serving and retired employ-

Sandhu said that IRWO had collected a considerable amount of penalty from him even though there is no facility there today. The completion certificate taken has also been given without any verification and without any basis. completion certificate issued



by authorities with so many conditions in which there is a blatant violation of the safety by laws. when the entire Building will be inspected there will be so many scams will come out. IRWO has done fraud in the lift purchase. which the IRWOs have installed in latter stage At least four to five lake

rupees have been cheated in the manufacture of each Flat. Due to which each society member has been cheated by IRWO at least five lace Rs on each flat cost. The wooden work done by IRWO is also of a low standard. The door frame is of inferior quality. If the cement is tested the only send will come out. Anyone can check it. Electric wires are inserted either straight or parallel or vertically inside the walls never diagonally while this type of fraud has been done to protect the cables. electrical switches and board are also of lower quality. Miles said that the seepage of water is on every floor and flat because IRWO has not even put the water line properly. When the water comes with pressure from the tank placed on the 15th floor the pipeline cannot bear the pressure due to which there is water leakage on every floor. IRWO has no solution to correct this and the flats are

getting spoiled due to water

leakage. The black tiles which

have been installed on either

side of the lift have lost their

place. Plastic welding has been done under the walls. The flat plaster can be scraped off with a spoon. The boundary wall that IRWO has built allows dogs and other animals to jump in from the nearby open deserted areas threatening their lives. The electricity problem always remains, and the cost of the DG set is also on the flat holder.Sandhu said that in 2015, some members of the society had presented a case against the IRWO in the National Consumer Court Delhi regarding all these issues. whose case number is CC 994 in 2015. IN The Honourable Court after getting time by IRWO did not respond twice. a penalty of 25 thousand has been imposed on IRWO. The next hearing is February 1, 2022. All the old and retired employees are sitting in the hope of the honourable Court that the Court should get rid of them from the frauds and price hikes done by the IRWOs

KN Singh said that IRWO, an organization created for the interests of the employees can do such type of fraud no one can think, now how railway employee can trusting whom, the employees buy flats for themselves by investing their lifetime earnings. IRWO's Sonepat Kundli Yojana is not suitable for residential and old age persons. while on the other hand, there is no provision for fire safety. If there is

a fire in the building, there is no security. According to the out security arrangements in high-rise buildings, NOC and completion certificates cannot be issue so how IRWO got this certificate. should also be investigated by CBI. Today every person wants to live in a safe place

so retired and serving railway employees keeping the intention of residing near Delhi have chosen the IRWO Kundali scheme. Invested their lifetime earnings in the project of IRWO Sonipat Kundli, but neither got a safe building nor did they are able to live there. IRWO's fraud has increased the cast of flats are beyond the limits. and there is no one to listen to. Now the Railway Minister himself should pay attention to this and send investigation of Sonipat Kundali scam to CBI. The employees believe that if the Railway Minister do the CBI investigation of the sonipat kundli project, then definite scam come out . Evidence of sub-slandered construction material is present in every flat.

The way IRWO has played the game of misleading the employees . data to rob the employees is present in the calculations. the land fraud needs to be opened because why were the flats sold by horoscope planning in the employees who were buying the flats in the name of the horoscope now when the truth has

come in front of them their full amount should be returned with interest to employee they dont want to leave in sonipat kundli. this is a judicial principle. IRWO cannot force anyone to take a flat at another place by telling one place. This is a long battle. The links to this IRWO scam are very long.
