In 2015, she was made the first woman governor of Jharkhand. Former President V.V. Giri was also born in Odisha, but he was originally from Andhra Pradesh.

Murmu's life witnessed many crises and struggles, which shows her vitality. Apart from being a widow in her youth, she didn't feel any mental breakage even with the death of two sons. During this, she continued to encourage the entire family including her only daughter Itishree. Her eyes moistened when she was being administered oath as the Governor of Jharkhand. She is an ideal and courageous woman of religious rites. They have a special influence on Indian culture and rituals. Udaipur: A 62-year-old patient living in Chittorgarh, Dalu Jatia, started losing his vision ten months ago due to the bite of a poisonous mosquito in his eyes. In this case, the patient visited several private hospitals and took medicine, but there was no improvement. The lens of the patient's eye (cornea) was damaged, and the cataract was also ripe; the patient could not perform routine tasks.

The patient is a farmer by profession and is a beneficiary of Chief Minister Chiranjeevi Yojana. He was brought to Geetanjali Medical College and Hospital at the suggestion of the patient's relatives

Ophthalmologist Dr. Rishi Mehta said that the patient's complex operation took two hours, during which three serious problems were diagnosed:

1. Cataract was diagnosed

2. Lens transplant done

3. Eye transplant done

Dr. Rishi said that cornea was procured for the patient from Eye Bank of Jaipur. The first complex operation of this kind was done at Geetanjali Hospital.

CMHO examined the status of the Chiranjeevi scheme

To review the facilities being provided in private hospitals under the Chief Minister Chiranjeevi Health Insurance Scheme, the flagship scheme of the state government, which offers free treatment to the common people of Udaipur, CMHO Dr. Dinesh Kharadi took stock of the scheme implementation in authorized the Pacific Institute of Medical Science Umrada and Geetanjali Medical under the scheme. During the inspection, Chief Medical and Health Officer Dr. Dinesh Kharadi, while directing on the shortcomings related to the scheme in Geetanjali and Pacific Hospital, said that along with the main gate of the hospital, information about Chiranieevi Yoiana and RGHS scheme and services should being provided in the hospital. The demonstration should also be done at the hospital's reception and emergency gates so that the patients admitted in an emergency can get information about the scheme. Patients can take advantage of the scheme by providing necessary documents within the stipulated period. During the inspection at Geetanjali Hospital, signage boards of Ayushman Bharat Health Insurance Scheme were found at the reception counter of the hospital, which the CMHO directed to get replaced immediately and the Chief Minister Chiranjeevi Health Insurance Scheme.Dr. Kharadi said that the department is preparing a booklet of packages available under the scheme, which should be kept at the reception, emergency, and registration counters in the hospital so that any patient who comes to the hospital can be informed about the package. Chiranjeevi's complaint box should be present in every hospital. CMHO Dr. Kharadi was directed to put up a separate complaint box for any complaint related to Chiranjeevi Yojana in the hospital. If any person makes a complaint related to the scheme, it should be dis-

posed of on priority by the hospital administration. Along with this, the number of the planning coordinator of the CMHO office should also be marked there so that the complainant can complain to the office if the hospital does not listen. Know the reality by communicating with the beneficiaries of the schemeDuring the Pacific and Geetanjali Hospital inspection, Dr. Kharadi interacted with the patients admitted to the orthopedic ward in the hospital and inquired about the treatment and facilities. He asked that money not be taken even after admission to the scheme. Given information about free treatment under the Chiranieevi scheme. all the patients thanked the state government for this scheme. During this, Dr. Kharadi informed the relatives of the patients about the system and inspired other people to join the scheme. During the inspection, the patients admitted under the Janani Suraksha Yojana in the Pacific Hospital also interacted. The patients were informed about the utterly free treatment being provided by the hospital. During the inspection, Geetanjali Hospital made money from some patients for consultation and examination in the OPD before admission. In contrast, there is a provision to return the said amount to the patient after being admitted per the scheme's rules. On this, Dr. Kharadi directed the hospital administration to repay the amount immediately and restrained so that such complaints are not received again in the future.Dr. Kharadi told that a complaint was also received from Pacific Medical College, Bhilo Ka Bedla, in this regard, in which DPC Sharad Patidar has directed to return the amount of Rs 6300 taken from the patient by talking to the hospital administration over the phone and the hospital administration has been given back in this regard. A notice has also

been issued, and a reply has been summoned.
