This has created a new challenge for the court and judicial institutions, and for the country's democratic and constitutional fabric, and requires a collective and collaborative response from the Judiciary, the legal profession, and the media.

For this reason, Dr. Rohit gave four chemotherapy cycles, which ended on August 1; after four chemotherapy, the patient started responding well, called VGPA (Veri Good Partial Response) in medical language, given which Dr. Rohit did Bone Marrow Transplant. The mindset was made, but patient Dilip Singh was about to be discharged from his government services on August 31, so he expressed his desire to do it after the completion of his retirement because there was lit-

On September 2, the patient Dilip Singh came again for treatment, and his transplant was started, which was completed on September 22. Vomiting and diarrhea, etc., were natural in the transplant, but the team of Dr. Rohit and the Head of the Intensive Care Unit of Ananta Hospital, Dr. Prateek. handled it well and played an essential role in completing the transplant, and on September 22, the patient was Dilip.
