## Live After Death: National Organ **Donation Day Workshop at RNT Medical College**



### **Over 600 People Pledge** to Donate Organs

Udaipur(Dr. Munesh Arora): In celebration of National Organ Donation Day, a public awareness workshop titled "Sawaal Aapke, Jawaab Hamare" was organized at the New Auditorium of Ravindra Nath Tagore Medical College on Saturday. The event aimed to highlight the importance of organ donation and encourage more people to pledge to donate their organs. Over 600 attendees took the organ donation pledge during the workshop. Experts from RNT addressed questions on topics including liver, kidney, brain, and heart dona-

Inaugural Address:

Dr. Vipin Mathur, Principal and Controller, welcomed the attendees and emphasized the need and significance of organ donation. He mentioned that one donor can save the lives of 7 to 8 people through organ donation, thus living on even after death. He referred to the historical example of Maharishi Dadhichi, who donated his body for a noble cause, creating a weapon from his bones to defeat evil. Dr. Mathur highlighted the lack of awareness in India about organ donation, which prevents many patients from receiving the organs they need, and encouraged more people to consider organ donation.

#### Addressing Inquiries:

A panel of experts, including Dr. Vipin Mathur (Senior Gastroenterologist), Dr. D.K. Sharma (Gastro Surgeon), Dr. Mukesh Sharma (Cardiologist), Dr. Vinay Nathani, Dr. Tarun Ralot (Neuro Physician), Dr. Gaurav Jaiswal (Neuro Surgeon), Dr. Varun Laddha (Urologist), and Dr. Sunil Gokhru (Transplant and Organ Retrieval Nodal Officer), answered various questions from the attendees. The experts advised maintaining a healthy lifestyle, consulting specialists when ill, and not discontinuing treatment without a doctor's recommendation. They discussed the adverse effects of self-medication and provided detailed information on organ transplants and brain death. The workshop was conducted by Dr. Rajveer Singh and Senior Nursing Officer and Transplant Coordinator Harish Choubisa. Pledge to Donate:

Approximately 600 participants, including RNT Medical College staff, medical and nursing students, and social workers, took the organ donation pledge. Additionally, over 60 participants registered their pledges on the NOTTO website and downloaded their certificates. Interested individuals can scan a QR code to register their organ donation pledge and download the certificate.

Honoring the First Organ Donor's Family:

The family of the first brain-dead organ donor from RNT Medical College, late Mankalal from Neemuch, Madhya Pradesh, was honored with shawls and turbans, along with a certificate of appreciation. Various events were held during the Organ Donation Awareness Month in July 2024, including quiz competitions among PG and UG students, essay and slogan competitions among nursing students, and rangoli and poster presentations. ## **Education Department's Unusual Directives Cause Confusion Among School Principals**



Banswara: Recent directives from the Rajasthan state government have left school principals in a state of confusion as the education department initiates a review of employees appointed over the past five years. The department has mandated principals to verify that the individual who took the exam is the same as the one currently employed, a task that many find challenging and legally questionable.

Concerns Raised by Rajasthan Teachers' Association Siyarama: Siyarama Sharma, the state administrative president of the Rajasthan Teachers' Association Siyarama, expressed concerns over these directives. He highlighted that recruitment agencies conduct thorough examinations and send all relevant documents to the Directorate of Education in Bikaner. Following an impartial review, these documents are then sent to district levels where another round of verification occurs before allocating schools to the appointees.

Issues with the New Verification Process:Once at the schools, newly appointed teachers complete several affidavits and begin their duties. However, the current directive requires school principals to certify the authenticity of the appointments, despite having no involvement in the initial recruitment process. Sharma pointed out that principals have never played a role in detecting fraud in these cases.

Responsibility Lies with District Officials: The onus of document verification lies with district inspection teams and the District Education Officer, who should be held accountable for any discrepancies. Sharma noted that for the past five years, a similar set of officials has been overseeing the recruitment process in Banswara, hinting at potential collusion. He called for FIRs against these inspection teams and their immediate dismissal from service.

Difficulties in Implementing the Directives: General Secretary Naveen Kumar Sharma emphasized the impracticality of the directive. Principals lack the means to verify that the individual who took the exam is the same person now employed. Identifying candidates who used proxies or cheated during exams is also beyond their capability. Consequently, the investigation has been reduced to merely verifying academic documents.

Beyond the Principals' Capabilities: The organization argues that examining application forms, photos, signatures, and other certificates is beyond the principals' remit, especially when dealing with forged disability or sports certificates. Given that documents undergo three to four levels of scrutiny before appointments, it is unreasonable to expect junior

Past Instances of Harassment:: Siyarama recounted an incident from 2008, where a teacher at Nutan School who exposed fake candidates in a D.L.Ed exam faced relentless harassment from the department. This teacher's efforts led to an FIR being filed by the assistant center head instead of the center head, raising concerns about higher-level interference and inadequate protection for whistleblowers.

Skepticism Over Investigation Integrity: The recent actions against the District Education Officer, who was made a scapegoat and later reinstated, further fuel suspicions of superficial investigations and administrative cover-ups.

Call for High-Level Investigation: In light of these issues, there is a call for a comprehensive review to ensure fair and transparent procedures, emphasizing that accountability must be established at all levels to prevent future miscon-
