Vantara Under Watch

The Supreme Court of India's decision to order a probe into the functioning of Vantara, the vast zoological facility in Jamnagar linked to the Reliance group, is both timely and necessary. For months, allegations have swirled regarding irregularities in the acquisition of exotic animals, lack of transparency in imports, and the possible fuelling of the illegal wildlife trade. By forming a Special Investigation Team (SIT) under the leadership of former Supreme Court judge Justice J Chelameswar, the Court has reaffirmed that no institution, however powerful, is above scrutiny.

The questions surrounding Vantara go beyond the fate of a few species. They touch upon India's international obligations under the Convention on International Trade in Endangered Species (CITES), the ethics of sourcing animals from questionable suppliers, and the broader principles of conservation. If even a fraction of the allegations prove true, the sanctuary risks becoming a symbol of exploitation disguised as rehabilitation.

in India. Reports critical of Vantara have too often been withdrawn under pressure, even as international outlets continue

their investigative work. This contrast not only highlights the challenges of press freedom in corporate-linked matters but also reveals how public debate is being stifled in a democracy that claims transparency as a virtue.

The SIT's task is not just to verify compliance with laws and conventions but to restore public confidence in the system. The probe must be rigorous, independent, and insulated from influence. It is essential that its findings be made public and followed by concrete reforms in wildlife gover-

India cannot afford to let corporate ambition overshadow its duty towards nature and biodiversity. Conservation cannot be reduced to a spectacle of exotic animals; it must be rooted in legality, ethics, and ecological responsibility. The Supreme Court has taken the first step. It is now upon the SIT, the government, and civil society to ensure that truth prevails and accountability is enforced.

In thanking the Supreme Court for this intervention, we also remind ourselves that vigilance in matters of wildlife and environment must never waver. The protection of nature is not a privilege to be outsourced — it is a collective duty.

Refinery Gift for Rajasthan on Diwali, Minister Hardeep Singh Puri Gives Strong Indications

Rajasthan is set to receive a major industrial boost this Diwali as the long-awaited refinery project in Pachpadra, Barmer district, is likely to be inaugurated. Union Minister for Petroleum and Natural Gas, Hardeep Singh Puri, has hinted that the formal commencement of operations could take place around the festive season.

On Sunday, during the inauguration of the refinery's stateof-the-art control room in Balotra's Pachpadra area. Minister Puri assured that both the central and state govern-

ments are fully committed to completing this ambitious proiect within the stipulated timeline. He emphasized that the refinery, being developed as a joint venture between Hindustan Petroleum Corporation Limited (HPCL) and the Government of Raiasthan under the name HPCL Rajasthan Refinery Limited (HRRL), will have an annual production capacity of 9 million metric tonnes (MMTPA), including 2.4 MMTPA of petrochemical prod-
