Smart City Millions, But Udaipur's **Identity at Risk**

Roads Shrink, **Footpaths** Vanish, River Choked – The **Stark Reality** Behind the **Projects**

Udaipur(Dr. Munesh Arora): Under the Smart City Project, Udaipur has spent a staggering ₹940 crore completing 112 works. Yet, instead of offering citizens a modern and convenient city, these projects have exposed glaring loopholes. Roads have been narrowed under the guise of beautification, footpaths have disappeared, and the city's lifeline – the Ayad River – is shrinking due to massive encroachments and soil dump-

> **Smart Roads** Without

The Hirnmagri "Smart Road," built at a cost of ₹36 crore, is the most striking example. A 10-15 feet wide park was constructed right in the middle of what used to be a 100-150 feet wide road. As a result, the once spacious road now feels congested even for vehicles. Footpaths, which should have ensured pedestrian safety, were either removed or swallowed by parking and encroachments.

At Surajpol, footpaths were completely eliminated in the name of road widening, while at Udiapol, the existing footpath was handed over to street vendors. Even cycle tracks and food corners have been overtaken by shopkeepers and encroachers.

Smartness

Encroachers have been far more active than beautification projects along the Ayad River. In Bhupalpura and Krishnapura, influential individuals dumped nearly 400 truckloads of soil into the riverbed, raising its level by as much as 8 feet. At several spots, 30-feet-wide roads have been carved through the river by simply dumping soil.

In Kunpura, over 100 trucks of soil were used to widen the causeway, turning it into a permanent vehicular road. Near Bhupalpura ground and the CPS bridge, private landholders filled in riverbed farmland, even constructing housesdespite legal restrictions allowing only farming in such land.

Old Surveys and Ignored **Red Marks**

Back in 1990, the Ayad River was 102 meters wide.



Today, government records show it has shrunk to just 50-55 meters, and in some places, only 37 meters remain. Fifteen years ago, the Urban Improvement Trust and Municipal Corporation marked

encroachments with red boundary marks. Many of these marks still exist, but no action was taken. Instead, Smart City works erected walls and beautification structures while ignor-

Leaders and Officials **Acknowledge** the Crisis

MLATarachand Jain admit-

ted that encroachments have strangled the river and stressed that restoring the Ayad to its original form is only possible by acting on the old red-marked survey boundaries.

District Collector Namit Mehta assured that a new survey will be undertaken and encroachments removed to revive the natural flow of the

Supreme Court Directs Aadhaar Inclusion in Bihar Electoral Rolls

Clarifies Aadhaar as Valid Identity, Not Citizenship Proof New Delhi: In a landmark ruling on Monday, the Supreme Court directed the Election Commission of India (ECI) to accept Aadhaar as the 12th valid document for inclusion in Bihar's electoral rolls as part of the ongoing Special Intensive Revision (SIR). The order comes amid complaints that election officials were refusing to recognize Aadhaar despite earlier instruc-

Abench comprising Justices Surya Kant and Joymalya Bagchi emphasized that while Aadhaar cannot be treated as proof of citizenship, it remains a legitimate indicator of identity and residence. "The Aadhaar card shall be treated as the 12th document by the ECI. However, authorities may examine the validity and genuineness of the card itself. Aadhaar will not be treated as proof of citizenship," the bench directed, also instructing the poll panel to issue immediate field-level instructions. The court's intervention holds significance as it compels

the ECI not only to treat Aadhaar on par with the existing 11 approved documents but also to verify its authenticity for establishing voter identity and residence. This decision comes over two months after Bihar's electoral revision exercise began, during which much of the field survey and door-to-door verification had already been completed.



senior advocate KapilSibal, representing the RashtriyaJanata Dal (RJD), accused the ECI of deliberately excluding Aadhaar. Booth-level officers (BLOs) are being pressured to accept only

the 11 notified documents. How can this be an inclusive exercise if a universal document like Aadhaar is rejected?" Sibal

The ECI, represented by senior advocate RakeshDwivedi, maintained that Aadhaar was already being accepted but cautioned against misusing it as a proof of citizenship. He highlighted that the commission has a constitutional mandate to verify citizenship while preparing electoral rolls. The bench, however, raised concerns over discrepancies

between the commission's claims and the instructions provided to field officials. Justice Bagchi stressed that while Aadhaar cannot establish citizenship, it carries legal weight under the Representation of the People Act as a proof of identity.

The existing 11 documents include birth certificates, passports, matriculation certificates, government-issued identity cards

The ruling followed intense or pensions, permanent residence certificates, forest rights courtroom arguments, where certificates, caste certificates, NRC documents, family registers, land documents, and identity documents issued by government or public sector units.

> Senior counsels Abhishek Manu Singhvi and GopalSankaranarayanan supported Sibal's plea, urging the explicit inclusion of Aadhaar. The court noted that most of the approved documents do not serve as proof of citizenship, except for passports and birth certificates, making Aadhaar's inclusion in line with the objective of inclusive electoral verification.

> The controversy has gained urgency in the context of Bihar's SIR, where nearly 6.5 million names were excluded from the draft rolls last month. Opposition parties allege that genuine voters are being disenfranchised due to technical barriers and inconsistent instructions, while the ECI maintains that the revision is essential after nearly two decades without such an exercise. The Supreme Court's clarification makes it unambiguously clear: genuine citizens must be included in the rolls, while attempts to claim voter rights through forged or invalid documents will not be tolerated. The ruling now provides a framework for balancing inclusivity with the integrity of the electoral process, marking a decisive moment in Bihar's ongoing electoral roll


India's Only Fair Dedicated to Railway Heroes-

Dr.VivekBhatnagar Emphasizes Knowledge and Skills as Pillars of a **Prosperous Society**
